- 8 persons & for projects located w/in the Revitalization Area.
- 9 • Unused funds in the Building Demolition budget line-item are eligible to be
- 10 reallocated to the Charlie's Place project.

12 **Issues:**

- 13 • The resolution reduces the Building Demolition project by \$10,200 & increases
- 14 the Charlie's Place Revitalization Project budget by \$10,200.
- 15 • The Charlie's Place Revitalization Project includes renovating the house & the
- 16 remaining motel units into adaptive spaces.
